DIRECTIONS FOR USE

BLACK ULTRA can be applied to most vegetable and cucurbit crops, field and row crops, deciduous fruit and nut trees, grapes, berries, olives, avocados and citrus. May be applied via centre pivot irrigation systems. When mixing with UAN, Ammonium Poly Phosphate or Aqua Ammonia a dilution of BLACK ULTRA with an equal volume of water is recommended.

BLACK ULTRA is non-phytotoxic when used as directed. Mixing with irrigation water for field storage is generally not recommended. Products blended with irrigation water should be used immediately and not stored for prolonged periods.

SOIL APPLICATION RATES

BLACK ULTRA may be applied pre-plant, as a starter, side dress, fertigation, top dressed or applied foliar to the soil. May be diluted with water to ensure uniform distribution. May be used as a pop-up or in furrow at 5 to 10 Litres /ha.

VEGETABLES & FRUIT CROPS, FIELD AND ROW CROPS: Use 5 to 10 Litres /ha. Repeat applications may be beneficial.

ORCHARDS & VINEYARDS: Use 5 to 10 Litres injected 7.5 to 13 cm deep at the drip line or surface band and water into the soil. Repeat applications may be beneficial.

FERTIGATION APPLICATION RATES

CROPS: Use 5 to 10 Litres /ha per irrigation. Continue irrigation for a minimum of 2 hours after application to flush lines and to maximize nutrient distribution with drip and micro sprinkler. Repeat applications may be beneficial.

APPLICATION THROUGH DRIP IRRIGATION – inject after irrigation filter.

TRANSPLANT WATER – FIELD & ROW CROPS, ORCHARDS & VINEYARDS, VEGETABLE & FRUIT CROPS: Use 5-10 Litres per ha, not to exceed a 3% solution of BLACK ULTRA to water.

FOLIAR APPLICATION RATES

FIELD & ROW CROPS, ORCHARDS & VINEYARDS, VEGETABLE, TURF & FRUIT CROPS: Apply 2.5 to 15 L/ha with the appropriate dilution for adequate coverage. A maximum concentration of 1:10 Actagro Black Ultra® to water should be used for foliar applications. Repeat applications may be beneficial.

GENERAL INFORMATION

CAUTION: DO NOT apply with calcium based fertiliser's such as Calcium Nitrate or Calcium Thiosulfate. Fertiliser solutions with a pH of 5 or less may not be compatible. Combining with liquid fertiliser solutions is more effective if done at a blending plant. CAUTION: Foliar application of BLACK ULTRA close to harvest may leave a brown residue on the harvestable portion of the crop. Rainfall, sprinkler irrigation or high humidity should alleviate this condition.

MIXING INSTRUCTIONS

BLACK ULTRA disperses well in water with a minimum of agitation. It may be combined with most fertiliser solutions using adequate agitation during mixing. Dilutions with water may be made at any time.

1. Partially fill tank with water and start agitation.
2. Add BLACK ULTRA slowly to the circulating mix and mix thoroughly.
3. While agitating, add the fertiliser product into the BLACK ULTRA and water solution.
