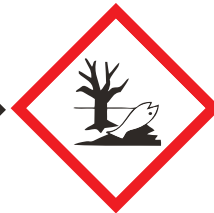
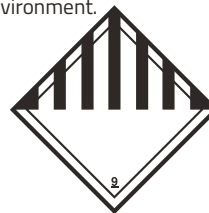

EZYFLOW NANO TRIPLE may be applied through liquid injection at seeding time, foliar application or as fertigation as required throughout the growing season.

CROP	RATE / Ha	WATER RATE GUIDE L/Ha	COMMENTS
WHEAT, BARLEY, OATS, TRITICALE, COTTON, PULSES, LEGUMES, CORN and RICE	0.3 - 1L (Foliar) 0.5 - 1L (Liquid Injection)	50 - 100L	Foliar applied at the 3 leaf stage. An additional application may be required prior to flowering. Liquid injection at seeding time.
POTATO	3L	500 - 1000L	Foliar applied at 4-6 leaf stage with follow-up applications as required.
TRUFFLES	2 - 4L	500 - 1000L	Apply through irrigation or spray onto ground as needed once or twice per annum, or as directed by your Agronomist.
VINES	1 - 2L	500 - 1000L	Foliar apply at 3 weeks prior to flowering with additional applications as required.
BEANS, BRASSICAS, CURCUBITS, ONIONS, LEAFY VEGETABLES, POTATOES, TOMATOES AND CHILLIES	1 - 3L	500 - 1000L	Foliar apply at 4-6 leaf stage with follow-up applications as required.
CITRUS	2 - 4L	500 - 1000L	Foliar apply at post harvest. DO NOT apply during budding or fruit development.
AVOCADO	0.5 - 2L (Foliar) 2 - 3L (Fertigated)	500 - 1000L	Foliar apply at pre-flower, between first and second fruit drop. Fertigate through irrigation to coincide with root flushes.
NUTS and STONE FRUIT	2 - 3L	500 - 1000L	Foliar apply at flowering, petal fall, post harvest and leaf fall, with additional applications as required.

DIRECTIONS FOR USE

SHAKE WELL OR INVERT SEVERAL TIMES before use as settling may occur after prolonged storage. Store in a closed, original container in cool, dry, well ventilated area away from direct sunlight. Triple or preferably pressure rinse container before disposal through the Drum Master program. Add rinsings to the spray tank.

MIXING: To ensure even mixing half fill the spray tank with clean water and add the required amount of product. Agitate thoroughly then add the remainder of water. Agitate thoroughly while carrying out spray operations. Reseal part-used containers immediately after use

PRECAUTIONS: Avoid application under extremes of climate, e.g. rapid drying conditions, extremely slow drying conditions, frost, rain, or when frost or rain are anticipated. Clean all equipment before and after use. It is advisable when applying for the first time or in conjunction with other products, to spray an initial small test area for observation before general application.

STORAGE AND HANDLING
