Starter	1.5 to 3 L/ha	May be mixed with liquid fertilisers or pesticides. If mixing, perform a jar test to assure compatibility. Mixing in the following order is recommended: fertilisers, chemicals, waters, then FOUNDATION LM. Liquid fertilisers in the pH range 5 to 9 are compatible with FOUNDATION LM.
Side Dress	2.5 to 5 L/ha	
Broadcast	5 to 10 L/ha	
Manure (Broadcast)	5 to 10 L/ha or 2 to 4 L/tonne	FOUNDATION LM can be injected into tank during fill process or injected directly into line in systems.

### STORAGE and DISPOSAL

**Storage:** Store product in dark fiberglass or plastic containers out of direct sunlight or UV light. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. PROTECT FROM FREEZING. DO NOT contaminate water, food, or feed by storage or disposal.

**Disposal:** DO NOT reuse container. Completely empty container into application equipment. Thoroughly rinse container, adding rinse water to the spray tank.

**Handling:** Avoid breathing fertiliser mists. Avoid prolonged or repeated skin contact. Avoid eye contact. Wash hands thoroughly after handling this product.

**If in Eyes:** Flush with clean running water for at least 15 minutes. If irritation persists, get medical attention.
